Adani - TEST has added you as a respondent to Vendor Registration Questionnaire. You can now submit updates for it when needed. Start by creating an account with Ariba Network. We would like to bring the below points to your notice before you initiate the registration process:

Once you register, **please don't upgrade to Enterprise account** which shall be chargeable basis for your transactions with Adani. Adani will not be responsible for making any fee payments on your behalf to SAP Ariba.
2. If you already have an existing SAP Business Network account with any other Customer & if you wish to use the same account with Adani, then please ensure it is a **Standard account** only. If you have an existing **Enterprise account**, then please **do not use** that account with Adani as you shall be charged hefty fees directly from SAP Ariba on recurring basis. Adani will not be responsible for making any fee payments on your behalf to SAP Ariba.

- **Invitation Email**

Supplier receives an email invitation from Adani for vendor registration in Ariba.

- **Access the Link**

Click the link provided in the email (refer to previous slide).

- **SAP Business Network Page**

Two options will be available:

- Login with Existing ANID
- Create New ANID

- **Account Setup**

- If the supplier already has an ANID, log in to link it with Adani.
- If not, create a new account to generate a new ANID.

Note – Please use standard Ariba account for register / login and we recommend not to switch / use enterprise account as this would have additional cost to the supplier.


