With reference to the captioned subject, we would like to inform you that the Company has divested its 100% stake in DC Development Hyderabad Private Limited ("DCDHPL") and Noida Data Center Limited ("NDCL"), Wholly Owned Subsidiary ("WoS") Companies on 22nd February, 2022 to AdaniConnex Private Limited (50% Joint Venture Company of AEL with EdgeConneX Europe B.V. Consequently, DCDHPL and NDCL have ceased as WoS of the Company.

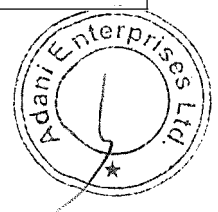

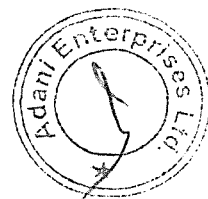
