We refer to our earlier intimation dated January 17, 2024, informing that AMG Media Networks Limited ("AMNL"), a wholly owned subsidiary of the Company, had acquired majority stake in IANS India Private Limited ("IANS").

AMNL has now executed a Share Purchase Agreement ("SPA") on January 21, 2026 to acquire the balance stake in IANS (as per details given below). Upon completion of the proposed transaction, IANS shall become a wholly owned step-down subsidiary of the Company.

The transaction is subject to the customary conditions. The information of the same was received by the Company on January 21, 2026 at 10:28 PM).
