With reference to the captioned subject, we would like to inform you that the Company has received an intimation (on March 31, 2026 at 06:18 P.M. IST) from Adani Agri Fresh Limited, ("AAFL"), a wholly owned subsidiary of the Company, that AAFL has divested its entire 50% stake in Vishakha Industries Private Limited ("VIPL") on March 31, 2026 and consequently VIPL has ceased to be an associate of AAFL.
