Dear Sir/Madam,

We, vide our letter dated January 22, 2026, had informed the stock exchanges of the execution of the share purchase agreement ("**SPA**") by AMG Media Networks Limited ("**AMNL**"), a wholly owned subsidiary of the Company, regarding acquisition of balance stake in IANS India Private Limited ("**IANS**").

As an update, we wish to inform you that AMNL has completed the acquisition of the balance 24% Category I shares (with voting rights) and 0.74% Category II shares (without voting rights) in accordance with the terms of the SPA. Consequently, IANS has become a wholly owned step-down subsidiary of the Company.

The intimation of the same was received by the Company on March 24, 2026 at 10.04 AM (IST).

The details of the above acquisition (as required to be furnished pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations and SEBI Circular No. SEBI/HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated 30<sup>th</sup> January, 2026) are enclosed as **Annexure 1**.
