Result of Postal Ballot

Pursuant to the provisions of Section 110 and other applicable provisions, if any, of the Companies Act, 2013 read together with Rule 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification(s) or re-enactment thereof for the time being in force), the approval of shareholders was sought by postal ballot as per details furnished in the Postal Ballot Notice dated 23rd February, 2019 sent to all shareholders, on the proposal for passing Ordinary Resolutions under Section 188 of the Companies Act, 2013 for:-

- (i) Divestment of 9,98,28,000 (100%) Equity Shares of ₹ 10/- each held in Adani Agri Logistics Limited and 50,000 (100%) Equity Shares each of ₹ 10/each held in Adani Agri Logistics (Samastipur) Limited, Adani Agri Logistics (Darbhanga) Limited and Adani Agri Logistics (Dahod) Limited to Adani Logistics Limited and;
- (ii) Divestment of 50,000 (100%) Equity Shares of ₹ 10/- each and 7,64,28,245 (100%) Compulsory Convertible Debentures of ₹ 100/- each held in Adani Power Dahej Limited; 50,000 (100%) Equity Shares of ₹ 10/- each and 2,81,53,939 (100%) Compulsory Convertible Debentures of ₹ 100/- each held in Adani Pench Power Limited; and 50,000 (100%) Equity Shares of ₹ 10/- each and 1,19,38,380 (100%) Compulsory Convertible Debentures of ₹ 100/- each held in Kutchh Power Generation Limited to Adani Power Limited.

Re : Report of Scrutinizer on passing of resolutions through Postal Ballot and Evoting

1. The Board of Directors of the Company, vide its resolution passed in the meeting dated 23rd February, 2019, appointed me as Scrutinizer for conducting the postal ballot voting process for passing Ordinary Resolutions as set out in the Notice of Postal Ballot dated 23rd February, 2019.

2. I submit my report as under:

The Company had completed dispatch of Notice of Postal Ballot dated 23rdFebruary, 2019 along with the Postal Ballot Form and a self-addressed postage prepaid Business Reply Envelope on 25th February, 2019 to its Members whose name(s) appeared on the Register of Members / list of beneficiaries as on 22th February, 2019 and also published Newspaper Advertisement in English and Gujarati (Regional Language) in Indian Express (English) and Financial Express (Gujarati) respectively regarding dispatch of Notice of Postal Ballot along-with Postal Ballot Form and containing all the matters required under Companies Act, 2013 and relevant rules on 26th February, 2019.

All Postal Ballot Forms have been received upto 6.00 p.m. on 27th March, 2019, being the last date fixed by the Company for receipt of the forms.

The postal ballot forms were kept under my safe custody before commencing the scrutiny of the said postal ballot forms.

Particulars of postal ballot forms received from the members have been entered in a register separately maintained for the purpose.

No Envelopes containing postal ballot forms were received after 6.00 p.m. on 27th March, 2019.

- 3. The Company has also offered E-voting through CDSL and the report contains the details through E-voting also.
- 4. The facility of E-voting remained open from 26th February, 2019 to 27th March, 2019.
- 5. We have unblocked the votes cast through remote E-voting in the presence of Mr. Raimeen Maradiya and Ms. Charmi Shah who were not in the employment of the Company.
